



Consent and Waiver

Dance Season 2024 - 2025

The undersigned, while either as a patron or as parent/guardian of any and all children who are under the age of eighteen (“18”) years and of whom are under the care and responsibility of the undersigned (“Dependant Registrants”), while, at any time on the premises of the Ellesmere Community Centre (“the Centre”), located at 20 Canadian Road, in the City of Scarborough, Ontario, hereby acknowledges, agrees and accepts the following terms and conditions as set out below:

1. Coarse language, aggressive, disrespectful or uncooperative behaviour is unacceptable. If inappropriate behaviour occurs, it may be recorded, reported and will result in removal from the program and/or the Centre.
2. The Pan-Messinian Association of Toronto (“the Association”), is not responsible for any property or items brought onto the Centre. The Association is not responsible for loss or theft of any items.
3. Any filming or photography is permitted by the Association during the registered program and/or drop in programming and the undersigned consents and agrees that it can be posted and shared on social media platforms, televised events and/or in print material in relation to the Association.
4. Parents/guardians must accompany children under sixteen (16) years of age to the program area for drop-off and pick-up only. Parents are not permitted at any time to enter the dance studio during class instruction or while dance classes are in session (unless otherwise stated). All questions or concerns raised by parents regarding the program must be directed to the Association’s board members directly and not to the dance instructors while dance classes are in session or in transition.

5. Children under sixteen (16) years of age do not need to be accompanied throughout the duration of the program (unless otherwise stated). All parents/guardians must remain outside of the Centre for the duration of the program. Parents/guardians are not permitted to remain inside the Centre throughout the duration of the program at any time (unless otherwise stated).
6. All dance students must wear their Association dance T-shirts at every class and at all times while at the Centre. There is zero tolerance for dance students who show up to dance class without their Association dance T-shirt. Students who do not have their Association dance T-shirt for class will not be allowed to participate and will be asked to leave the Centre.
7. The undersigned agrees to be responsible for leaving the Centre, including the community outdoor park and parking lot area, in the same condition as it was when the undersigned and/or the Dependent Registrant(s) entered onto it, including the proper disposal of all litter.
8. Vandalism, littering, destructive activity, including amplified sound or any activity intended to criticize, undermine, disrespect or disparage the Centre and/or the Association is prohibited and will not be tolerated in any way, shape or form and will result in the automatic and immediate removal from the Centre, the program and/or the Association itself.
9. No alcohol, drugs, marijuana use or vaping is permitted at any time at the Centre, including the parking lot and community park areas.
10. The Centre is intended for the use and enjoyment of the Association and its members and it is the responsibility of the undersigned to help ensure that it is a clean and safe environment for all. Failure to comply with this clause to the satisfaction of the Centre and/or the Association, may result in monetary charges for maintenance and/or repairs, that the undersigned may be entirely responsible to pay either on the undersigned's behalf or on the behalf of the Dependent Registrant(s), of which arises from the use of the Centre either by the undersigned and/or the Dependent Registrant(s).
11. I agree to release, indemnify and save harmless the Association and each of its officials, servants and agents, from and against any and all actions, suits, claims, executions, proceedings and demands which may be made or brought upon the Association, in respect of any costs (including legal fees), expenses, loss, damage, financial loss or injury

(including sickness or loss of life) arising by reason of my own or by the Dependent Registrant's participation in any activities offered by the Association, the Centre or by reason of the provision of medical care by the Association and/or the Centre, to me or my Dependent Registrant(s).

12. Failure to co-operate with the aforementioned terms and conditions may result in the suspension or revocation of program registration, Association membership and any associated privileges therefrom.
